## **OWI ARRESTS IN DENMARK**

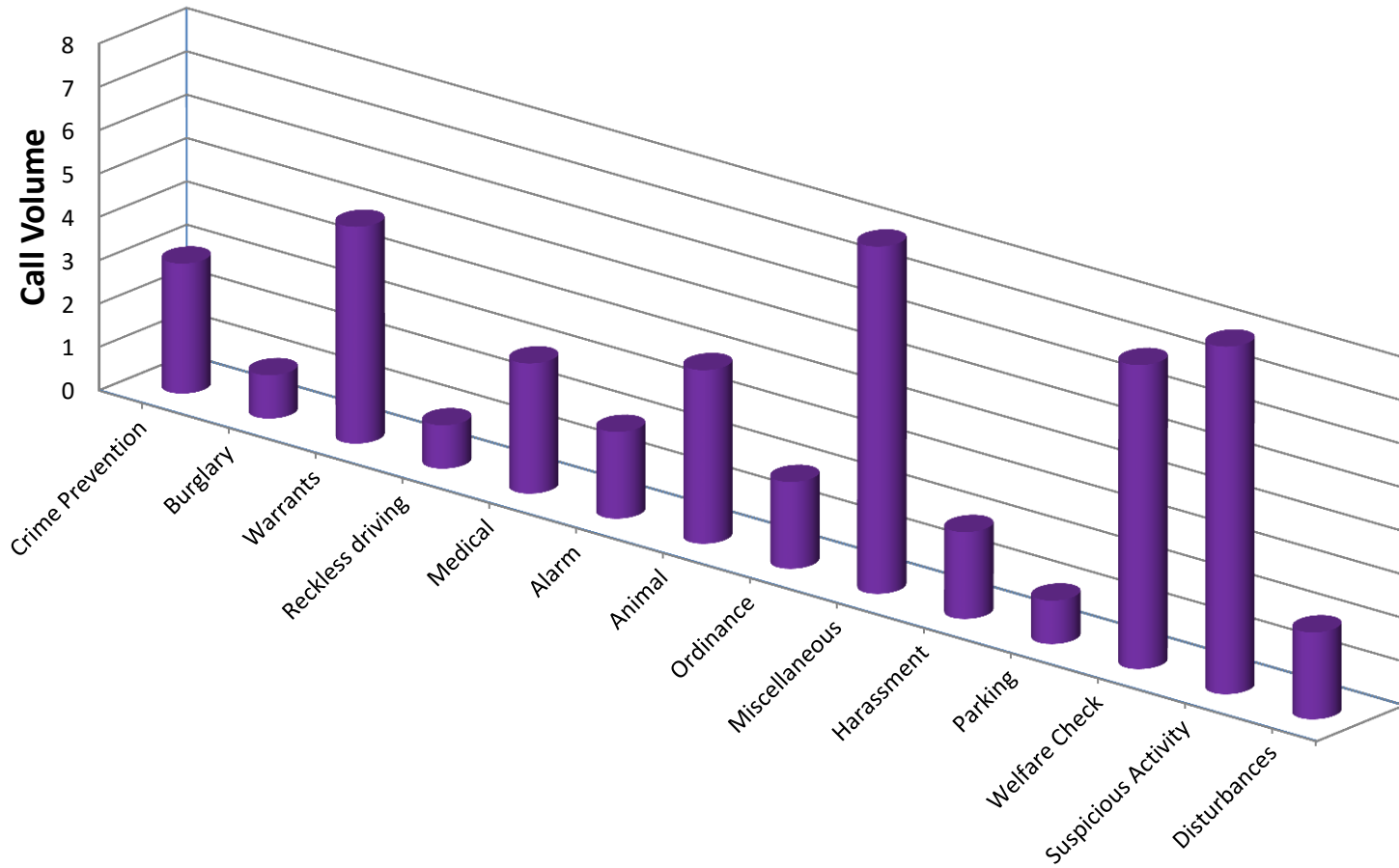
- There were 0 OWI arrest made.

- 08-01-16 Both DEOs attempted to pick up a male with an active arrest warrant. The male is also a possible suspect in a burglary.
- 08-02-16 DEO Dzekute was able to return a stolen ring to a resident. The ring had been recovered at a pawn shop and was returned to the proper owner.
- 08-03-16 Both DEOs worked with a member of the Brown County Sheriff's Traffic Team to set up the Metro Count on Woodrow St. The Metro Count was able to give us data on vehicle volume and vehicle speeds. The Metro Count was put out 07-27-16 and picked up on 08-03-16.
- 08-04-16 DEO Dzekute responded to Salm Partners for some drugs that were found in the building. The drugs were turned over and taken care of properly.
- 08-05-16 DEO Delebreaux was called to assist Manitowoc County with an accident. He was asked to control the traffic at the intersection of CTH KB and CTH R.
- 08-06-16 DEO Delebreaux was dispatched to Salm Partners for a temporary employee that had been drinking. The business wanted the male removed. He left on foot and was located walking. DEO Delebreaux and a county officer were able to transport the male to a safe location.
- 08-06-16 DEO Delebreaux was requested to assist a county officer with a disturbance in New Denmark. The disturbance was verbal and the officers were able to resolve the issue without any criminal charges.
- 08-08-16 DEO Dzekute attended the 3-day DARE training conference. There was a lot picked up to assist not only with teaching, but with other activities throughout the school year.
- 08-10-16 DEO Delebreaux deployed the speed board on Woodrow St. so people could be aware of the speed that they were driving.
- 08-10-16 DEO Delebreaux assisted the middle school band with traffic control.
- 08-17-16 DEO Dzekute, along with a county officer, attempted to pick up a male with an active arrest warrant. We were unable to pick up the male at that time.
- 08-17-16 DEO Dzekute picked up the Charger from Gandrud where it had been brought in for service.
- 08-18-16 DEO Dzekute took a damage report from Bielinski Excavating. One of their pickup trucks had a hole drilled in the gas tank while it was at the repair shop. At this time there are no suspects but if there is any information out there please contact DEO Dzekute.
- 08-21-16 DEO Delebreaux was requested to assist with a DRE (Drug Recognition Expert) evaluation at Aurora Hospital.
- 08-22-16 DEO Dzekute was requested to assist a county officer with a medical call at the Cedar Hedge Shell gas station. A male needed to be transported from Mc Donald's in Denmark to the gas station.

## **RESULTS OF WOODROW ST. TRAFFIC STUDY**

- The Metro Count was used to study the traffic on Woodrow St. The study was done from July 27 until August 3. The Metro Count was set up between West Woodrow Ct. and Oak St. The traffic study was not to be considered all inclusive. A street engineer is needed to interpret all the results and could give an all inclusive report. This report was used primarily to monitor the volume and speeds of the vehicles traveling on Woodrow St.
- During that week there were 5,560 vehicles that traveled down Woodrow St.
- The average speed traveled was 27.5 mph
- 81.42% of the vehicles were traveling 22-34 mph
- The peak times for traffic are as follows:
  - 07-27: 4pm.
  - 07-28: 5am and 4pm
  - 07-29: 5am and 2pm
  - 07-30: 6am and 3pm
  - 07-31: 10am and 6pm
  - 08-01: 5am and 4pm
  - 08-02: 6am and 4pm
  - 08-03: 6am
