President Mleziva asked the Board if they had any other questions regarding the Conditional Use permit other than what was discussed in the public hearing.

- Is there a way to anti-dust the process
- Maybe it should be done when it is not so dry (Tim Czarneski of Pro1 stated in the public hearing that is isn't completely dry when they screen it. He said it has 6% moisture.)
- We cannot set precedence for future businesses.

Wertel/Hargarten moved to approve the Plan Commission's recommendation to approve the conditional use application for Pro1 Property Services (VD-730), located at 655 Copenhagen Way as long as the screening machine is moved to the back, and the product has to be enclosed.

Discussion:

How do we enforce dust at other businesses in Denmark?

- Grinding can only be done when the wind is low
- The noise needs to be kept to a minimum
- The street needs to be swept if there is dust/debris in the gutters after grinding
