Currently, there is **1 open case** with BCSO investigative division. Both DEO continue to work with and communicate with the BCSO Investigators about current investigations.

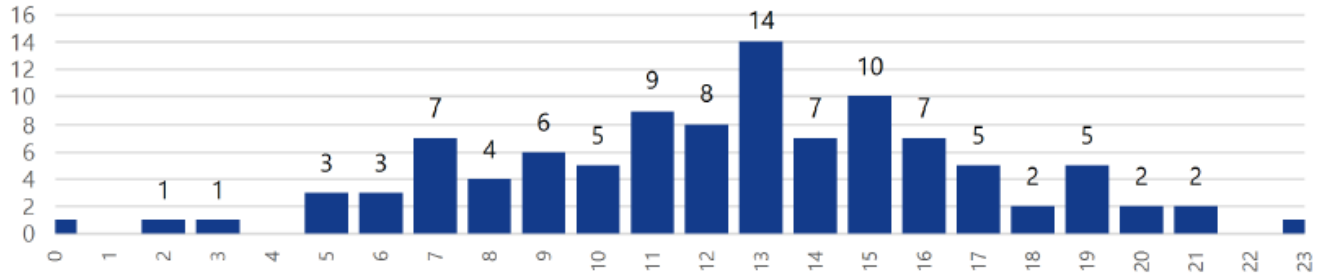

## INFORMATION BULLETIN

**Overnight parking** – opens up April 1.

– Prescription Drug Take Back Day at Village Hall, 10:00 a.m. – 2:00 p.m.

**Phone and Internet Scams** – do not give out any personal information over the phone. Scammers try to shock and intimidate victims into giving up personal information by threatening “arrest” or “warrants.” Also, they may pray on your decency by telling you a loved one is in trouble in another state/country. Be very skeptical of all phone/e-mail correspondence. Have frequent conversations with elderly/your aging loved ones and educate them about how to protect their asses.

**RING** – Stay tuned for April’s monthly report with special information about RING: Home Security Systems. DEO Verheyen will be attending a brief presentation on April 9.

**\*Road closures\*** County KB road construction will begin on April 1 and North Wall construction will begin on April 8.
