## IN THE COMMUNITY

**Denmark Branch Library** – DEO Verheyen continues to monitor Library events and be present when they arise. DEO Verheyen has scheduled ‘Story-time with an Officer’ on August 8<sup>th</sup> at 10:30 – 11:30 a.m.

**Village Rummage Sale** – DEO Olmsted was on bike patrol for the duration of the annual rummage sale on May 4<sup>th</sup>. Thank you everyone for a safe day.

**Ruby's Pantry** – DEO Verheyen continues to engage in Ruby's Pantry and will be at the June 25<sup>th</sup> pantry. DEO Verheyen worked with Denmark DPW to begin temporary No Parking on the north side of Prospect St during the pantry, due to the construction zone detour and volume of traffic that now travels Prospect. This will continue through summer during the pantry days.

**“Frogger” Crosswalk Enforcement Day** – Both DEO's participated in this regional event to bring awareness, educate, and enforce pedestrian crosswalk safety. Thank you to the Brown County Sheriff's Office Traffic Unit for assisting DEO's in this operating. During the 2-hour operation in the Village of Denmark, DEO's used (2) different location sites with crosswalks.

- **32** drivers correctly yielded to the pedestrian
- **17** traffic stops were initiated to make educational contacts
  - Of these, **(18) written warnings** were issued and **(4) citations** were issued (seatbelt violations)

Mark your calendar for future “Frogger” enforcement days: July 23<sup>rd</sup> and September 3<sup>rd</sup>. This is a regional event in all the Greater Green Bay Area!

## MEETINGS AND ASSOCIATIONS

DEOs continue to introduce and build partnerships with local businesses, including those in the Denmark Community Business Association (DCBA). DEOs continue to attend those **DCBA, Lion's Club, Denmark Neighboring Association** (DNA), and any special meetings including McMahon engineering, when applicable.

## TRAFFIC ENFORCEMENT

There were **27 traffic stops** initiated in the Village of Denmark in May.

County deputies and County Traffic Team continues to add extra patrol in the village to assist the DEOs.

Both DEOs are monitoring the construction zones and road closures. Note, a crossing guard location was added at N. Wall St/North Ave for the remainder of this school year. DEOs continue to monitor pedestrian safety and traffic flow, especially during school zone times at that intersection and others.

### Investigators

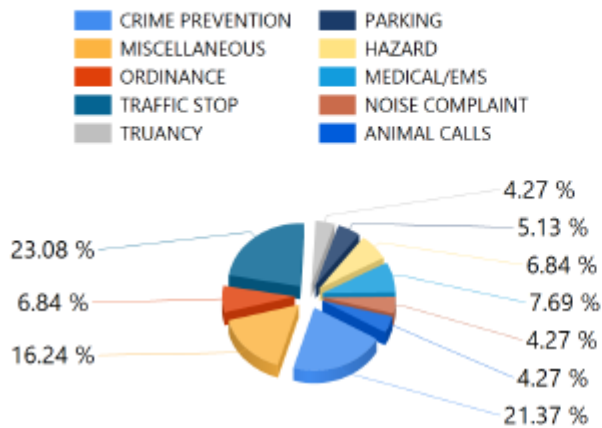
Currently, there is **1 open case** with BCSO investigative division. Both DEOs continue to work with and communicate with the BCSO Investigators about current investigations.

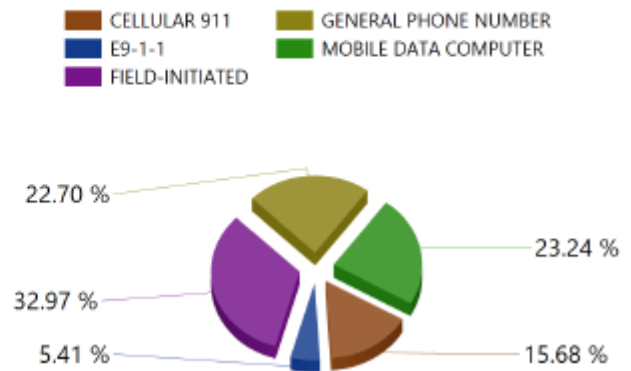

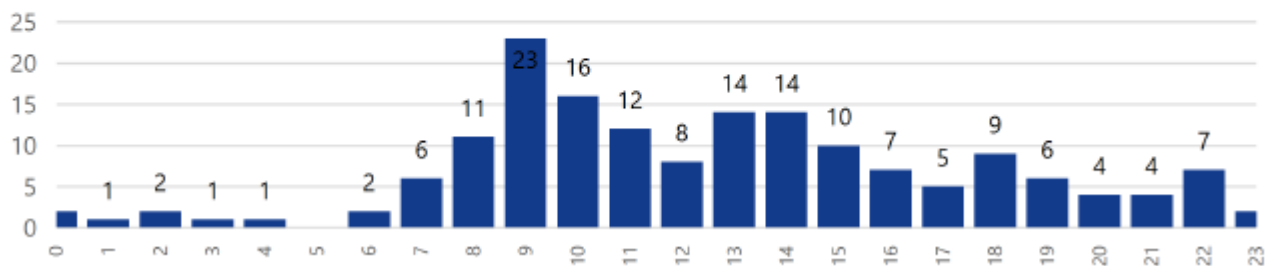
**Top 10 Calls for Service By Type**

### \*CONSTRUCTION\*

With the CTH KB construction detour route, please be aware and follow:

1. **Kellner St** is a one-way roadway.
2. **Prospect St** has a posted speed limit of 25 mph.
3. **Hager Rd** (detour route) speed limit is 25 mph.

These are residential roads and it takes a joint effort to keep everyone safe! Please watch for construction workers!

County Highway KB road construction began on April 1 and is closed with a detour route.
